

Burman and Slemrod explain for the average tax payer as well as those seeking more tax information how the U.S. tax system works, how it affects people and businesses, and how it might be improved. They contend that the timing of this book is good because both candidates for president in 2012 embrace tax reform, albeit with very different visions, and the debate about taxes has become a proxy war in the battle about the size and scope of government. Part 1 provides an overview of personal and business taxes in the U.S., and part 2 explains the costs and benefits of taxation. Part 3 reviews tax policies and tax reform. The authors conclude by explaining sensible tax reform ideas, including those developed by President George W. Bushââ  $\neg$ â,¢s blue-ribbon panel and President Obamaââ  $\neg$ â,¢s Bowles-Simpson Commission. This is an excellent, understandable book on a topic important to a wide range of library patrons. --Mary Whaley

I read this book last weekend and I thought it was excellent. The authors did a great job presenting complicated facts about the tax code, specific taxes, the incidence of taxes and more in a simple and neutral way. I say this even more comfortably that I am of a rather different school of thoughts than the authors. If you are interested in tax issues but don't know enough or you know a lot and simply want learn about how to talk about taxes in a way that won't put people to sleep, this book is a must read.

Tax policy and tax reform ideas seem to be a never-ending story in the news these days -- while the public seems more and more confused and lack an understanding about the fundamental principles needed to effectively evaluate tax policies. Burman and Slemrod do an excellent public service by offering this book in an easy to understand manner. The writing is crisp, clear and even at times funny (and not just funny to a tax economist). As the other reviewers on this page have noted, the authors do an excellent job presenting tax concepts in a non-politically biased manner. This book is useful for people on both sides of the political aisle and especially for citizens looking for a book to help explain the economic and public policy tradeoffs associated with tax policy. This book will also make an excellent primer for a public policy class on tax policy...and I will likely use it myself in future classes.Taxes are not only the price we pay for a civilized society, taxes are also the price we

pay as a society that uses the tax code to try and achieve social policy objectives, such as equality, income redistribution, home ownership, savings incentives, work incentives, healthcare coverage, economic stimulus, etc...the list goes on and on. These social policy goals have both economic and societal costs and benefits -- Burman and Slemrod do a good job explaining these tradeoffs. If everyone in this country read this book and came away with a proper understanding of the incidence/burden of various forms of taxation (Chapter 2) or how some tax breaks can rightly be classified as spending (Chapter 7 - Burman's letter to Jon Stewart of "The Daily Show" on tax expenditures is a definite must read), then we might actually be able to pass legislation and institute a tax system that we truly deserve...not the one we currently have.

With Congress confronting the fiscal cliff when it returns from Thanksgiving break, a book that looks at the US tax system is a timely primer for many of the issues that will be front and center in the budget debate. The book is well written and easy to understand. It provides easy explanations for many different tax structures and leaves the reader with an important understanding that the person who pays a tax may not be the ultimate payer of the tax.

I would wholeheartedly recommend this book to anyone interested in the basics of tax policy. In fact, it should be required reading for everyone. The authors clearly know their stuff and write well. The book is structured as a series of questions and answers that make it a fun, easy read. The authors also do a very good job of trying to be as objective as possible, relying on scholarly studies and reveal-world evidence to explain their points rather than asserting their own beliefs. Highly recommended.
