

This textbook is a wealth of information on the origins, classification, and sources of Children's Literature (which is the metric it should be reviewed upon, rather than whether it fits a particular worldview). However, if your sensibilities are easily wounded by approaching religious texts as stories, rather than as absolute truths, I suggest you look elsewhere.

This book fit my requirements for the Children's Lit. course I'm teaching next semester. Easy to follow and yet still very comprehensive.

This was easy to read on the kindle and on my computer. It is formatted just like the book, it's like you are flipping the pages of the textbook itself. With that being said, it did have the downside of not being readable on the basic kindles, just the color ones.

As far as textbooks go, this one was well-written, but I wish the links listed in the text to more complex bits had worked. Some of those lists for evaluation would have been great to read, but NONE of the web content worked. I think the issue is with the publisher, though, not the book itself.

I do not have access to Connect - which I need for my class. This is useless to me and now I have to purchase something else. Perhaps I read something incorrect but I am not happy.

I had to buy this book for a class, but ended up returning it - later I just borrowed a copy from the library if I needed it. Book is informational and helpful in understanding the themes of different genres of children's literature.

The book is good and full of information for the class and fulfills the needs of the class. I had used it before and think that there are some newer reviews out there, so I would expect some updates added to a newer edition. All in all, I passed the first class with an A and the second with a B.It is a very good book for the class and I couldn't tell you if there are an better available yet.

I rented this book and considered keeping it. It's got some great information but, just like many second editions, it is not very current. Many titles in it are too old to find even if I wanted to put outdated books on my shelves.
