

I bought this handbook during my third year of pharmacy school and wish I had bought it sooner. The chapters are nicely summarized and short. I read this prior to reading the DiPiro textbook, so that I would have a nice overview prior to diving into details. I read each chapter again prior to quizzes and exams. They contain all the pertinent info, as well as some very helpful charts. I continued to reference it during my 4th year APPE rotations, and brought it along with me to my PGY1 residency. This handbook is GOLD!

As a pharmacy student on rotations, this has been especially helpful. Although it's not entirely updated on recent guidelines, it is perfect for a refresher whenever I have topic discussions with my preceptors. It is organized and you can read up on an entire disease state within 10 minutes.
