

In addition to being a teaching faculty member, he serves the Department as the Director or Graduate Studies for the Master of Science in Criminal Justice and advisor of the Forensic Science Program. Prior to entering the field of college teaching, he was employed as a Special Agent for the Intelligence and Organized Crime Division (IOCD) of the Kansas Bureau of Investigation and later as a Senior Intelligence Agent for the Oklahoma Bureau of Narcotics and Dangerous Drugs. Dr. Lyman has authored several textbooks in criminal justice dealing with the areas of criminal investigation, policing, organized crime, and drug abuse. I already have a degree in Criminology, and thought to enhance my education by taking a lower level C.J. class. (plus, it's affordable fun, to take lower level classes - you get to be around people who share your personal interest, and most are enthusiastic. If you want to workout, it's cheaper than a gym membership - enroll in Yoga, Aerobics, Swimming for 2 or 3 days per week and get free access to the University's gym.) This book is very clear, and incredibly easy to read. However, for those with a more sensitive soul, some of the photos, particularly the ones of abused children, - understand there are raw elements in the book; be prepared. It was the best book for a Criminal Investigations course. It didn't talk over students heads, it wasn't verbose, it was succinct. Sometimes, I find that college book authors, put all their effort into proving that they are well educated, and end up sounding like Hemingway on acid, trying to explain quantum physics to cats. This author found the right balance. Lyman is able to educate individuals interested in Criminal Investigations, challenge them to learn, without coming off as confusing, overwhelming, or pompous.

Although only one chapter has been assigned and we are not using the MyCrimeKit, it just seems like a textbook, kinda boring with a few good features. The only particular thing I can say is that one of the assignments we had was not answered sufficiently in the book and I had to do additional research to be able to complete the task. I will update as we get further into it.
