Most students have laptops that don't have disk drives. The publishers could save money by simply providing the access code to online content. Maybe they could take that savings and put it into paper quality.

I like the layout and I found, along with other classmates, that this book was amazing. Informative--as law books tend to be. However, many law students can attest that studying law is not exactly fun. This book brought back the fun in law. You really felt like you were working your first case. I cannot give it high enough praises. The only drawback for some is the way the book does not exactly follow a linear line and your review chapters of the book multiple times. Still, I found that the reviews were relevant and easy to read. This is one class and book you are going to love.
