

I am a first year dermatology resident and I recently purchased this resource. My goal was to read

all the way through Bolognia this year and I have been taking notes in another review book as I go. This is cumbersome as I find myself having to add a plethora of important missing information. Since I bought this book I have realized that it is very comprehensive. It includes every important pearl from the corresponding text in Bolognia and I find myself not having to add anything. It is well organized and easy to follow with the bullet point type format. This will be my primary study source from here on out as I prepare for boards over the next two years. I am very excited to have such a reliable and thorough text to use. I highly recommend this review book to any dermatology resident!

As someone who took and passed the dermatology board certification exam this previous year, I just wish this was an available study resource at that time. The quality and breadth of information is superior to that of Jain (which was the go-to for boards studying but suffers from errors, outdated information, and omission of important topics), and the excellent figures and tables (often adapted from authoritative sources such as the Bolognia textbook) are a welcome addition as well. I find this book to be incredibly useful in clinic, both as a quick reference as well as a teaching tool for residents. I would wholeheartedly recommend this book to my residents and anyone else who is planning on taking the board certification exam in the future.

I am a PGY-2 and purchased the Kindle version of this book about 1 month ago and since then have used it solely as my primary study guide. Review of Dermatology will soon take the place of Jain in my study routine as it is well organized and very thorough. I highly recommend this to anyone looking for the most up-to-date and thorough board review book.

Comprehensive.... but a little hard to read... the pages are visually congested with the material presented as bullet points formatted in double vertical columns per page. They pack a LOT of info into each page, which leaves very little white space for annotating or other notes. The tables are mostly copied from Bolognia which, while comprehensive in nature, are sometimes long and not always conducive for review. Can't fault the content at all, but wish the content was presented in a more readable format.
