

There are some useful little nuggets here and there, but by and large the first half or so offers very little of value for someone interested in learning how to be a property manager. There are also several typos - garbage. As the book progresses, there are various sections with useful nuggets of information. By the time I got to the end of the book, I looked back and felt like there were enough bits of useful information for the book to not be a complete waste of time. Overall, I think it is OK.
