

This has very good information about general planning. Unfortunately, its not the up-to-date version that reflects the changes in the estate tax exclusion (\$5 million plus) nor the spousal exclusion carryover. The author tries to lighten up what might be considered a dull subject with some humorous references - as I went through the book I found them becoming tiresome. I used it as a refresher "course" and it was beneficial.

This book is totally out of date on the estate tax. The book appears to have been written before 2009. Don't buy it!

The average person with no fortune to plan for will benefit from this bookWe never really think about our own death, we know it will happen, but a surprising number of people leave no documentation or preparation for the items and property we own, or the insurance we have paid for to protect our loved ones, except to put a beneficiary on the insurance policy we have small and large. I am 56 and have nothing in place should I die tomorrow. Quoting "Who needs this book? Estate planning applies to everyone, yet a surprising number of people have done only a small part of what they need to do (usually just creating a will, which is very often out of date) "This book gives me the basics and also the more complex answers to estate planning, and some of the common mistakes people make....
