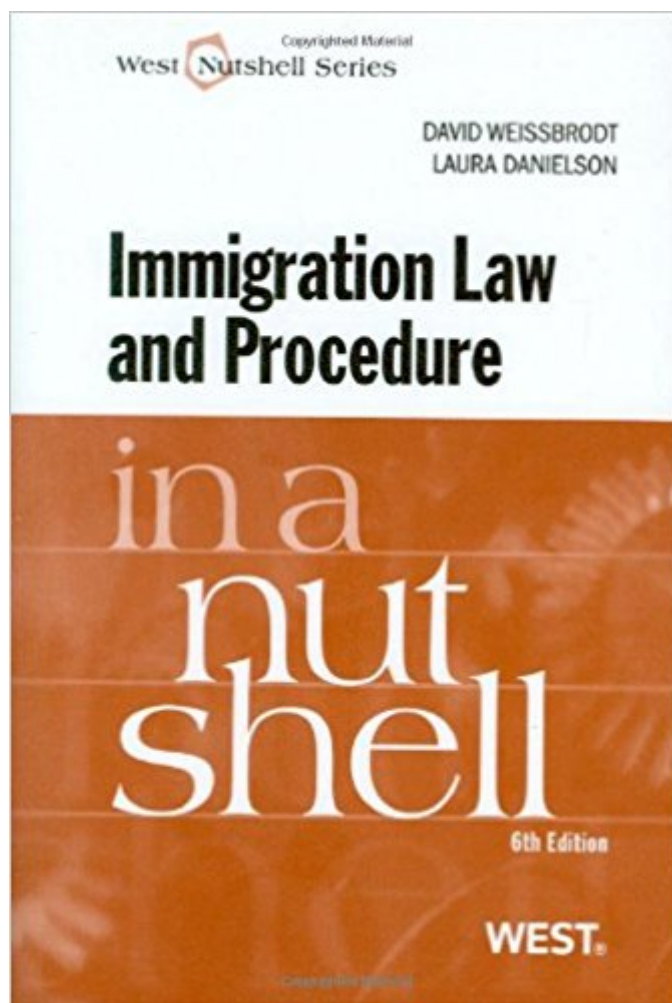

This is eh. If you go to class and stay caught up on the readings the Nutshell isn't particularly helpful. I was hoping for something that would help with my outline and all the code sections but this isn't it. The information itself is straight forward and fine, just not particularly needed as the book is quite clear. If you wanted to skip the readings this might be more helpful.
