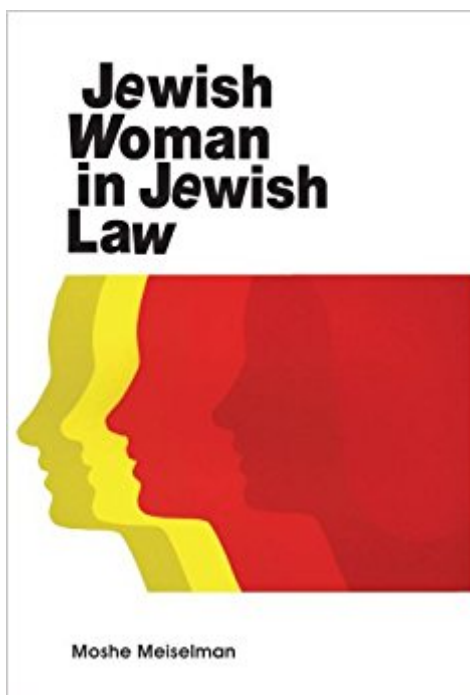

Excellent work. Lucid, erudite and thorough!

This is a consideration of the woman's role and status as defined by Halachah. It is possible to learn much from this work about the traditional view. It does not have however the kind of openness in response to questions of changing status due to developments in modernity that for instance the work of Rabbi Eliezer Berkovits has on the same subject.

Sorry to say this but he wasn't very informed on certain issues at the time he wrote this, which was when he was quite young. He says that nobody commented on the Yalkut but clearly the Magen Avraham does. He says the Maharal says women achieve greater heights, but bases that only on Derashot Al HaTorah 29, which only talks about Torah study and only says women are more tranquil. There are many Maharals that contradict such a notion and he didn't mention them (or know about them).

Good opinions start with good facts and Rabbi Meiselman has done a masterful job collecting the facts about the role of the woman in Judaism. Be prepared to toss out some stereotypes because this book really clears up the mystery.
