

This book is SO much better. Don't let its small width, confuse you. It packs a lot of information in a concise, easy to understand and relate-able way, almost everything presented in the larger books minus the extra practice tests. Not only does it tell you what to expect from the test, it tells you how to APPROACH the test itself, the sections an questions and the written aspect. The flow and content is presented clearly, no grammatical errors, format and style makes it easy to remember the tips. For me it made, me comfortable to take the tips and information presented and pass the exam. I just took the LSAT on Monday but funny thing was I felt comfortable. For those who study best without the fluff and just need to be confident in your skills.... this book is definitely for you.

This is just a terrific study guide for a very difficult test. I was given a free copy to review, which I eagerly accepted. I took the LSAT years ago and learned the truth of what UCLA's great coach Wooden used to say, "Failing to prepare, is preparing to fail." I didn't prepare well and I didn't do as well I I could have done. This guide is very thorough, including syntactical clues as well as the simple advice to make notes and mark up the exam as much as necessary to make things easier. It covers everything a good test taker needs to know, which is worth reviewing, even though you've had a lot of undergraduate experience. The only advice not included, and probably not provided for by the testers, is what to do if you wake up with the Flu and and a temperature of 102, as was my misfortune in 1973. Anyway, if you're determined to score the best you can, get this guide and try to take care of yourself.

I compared this book to several other books for the LSAT exam. I recommend this book in addition

to your study regimen because the price is pretty good for the content displayed. The book has 120 pages that are very detail oriented. One thing that is always useful is the expectations of the test this..book does a great job introducing the content that will be delivered. The only thing that I would change would be to have at least more strategies for the writing section portion of the exam other than that its very informational!

Preparing to take the LSAT can be frustrating and difficult, but this guide has been an excellent resource. It provides valuable information that is helpful in testing, including relevant facts and concepts. What helps this study guide stand out better than all the others is that there are also strategy ideas for test-taking that will help me (and you) get our best scores whenever we test. So much of it is being good at thinking through questions and having good critical thinking as a test-taker.
