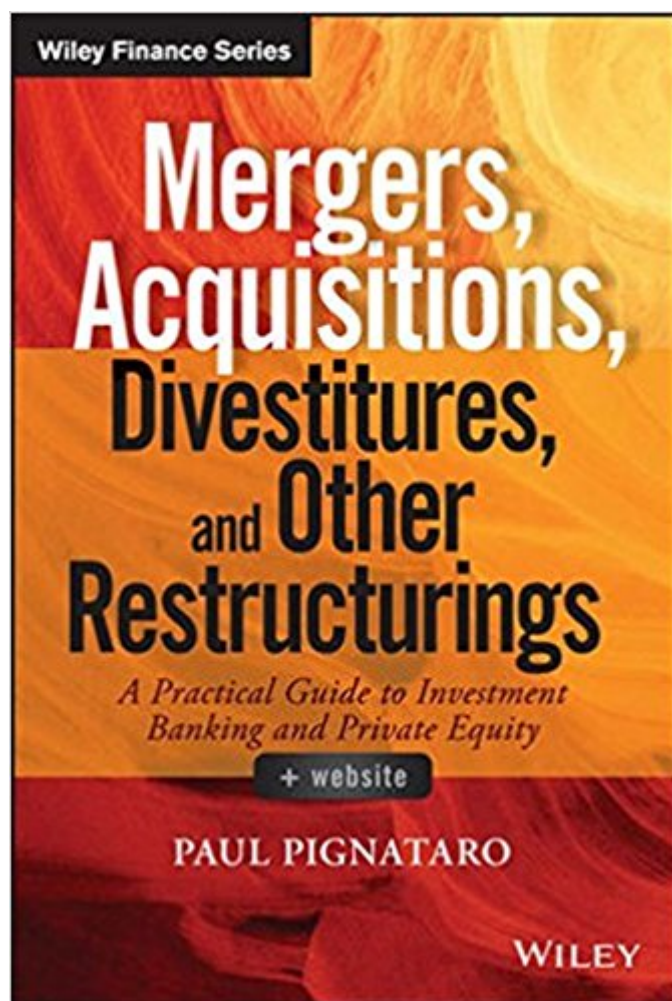

I wrote a review for his LBO book and also am writing a review for his new M&A book. Everything that I mentioned in the LBO book review also applies here. I think the really excellent thing about Paul's books is that they are very in-depth treatment on one particular type of analysis. Other books on valuation will just contain one chapter on LBO, one on M&A, etc. However, Paul book series are compartmentalized and standalone in-depth treatment that as a collective series will make you truly exceptional in both the sell side (i.e. IBD advisory) or the buy side. Anyone with experience in this field will know that just having this skill set and know how is a very lucrative skill set to have. If you truly want to be the next Bob Greenhill, Felix Rohytan, Ira Harris of M&A and you truly master everything in this book (as well as his other two books) then you will truly be in a position to generate real wealth for yourself as well as your clients and others.
